For 2022/23, the Fund held an investment portfolio managed by Vantage Wealth Management. Mr Frank Sciarrone was both a director of Vantage Wealth Management and a FES Super Board Member (to 18 August 2022). Payments made to Vantage Wealth Management consisted of investment management fees. All transactions with Vantage Wealth Management are conducted on normal commercial terms.

All Board Members were also members of the Fund. Board Members contributed to the Fund on the same terms and conditions as other members and are subject to the same terms and conditions as all members.
